4. that the undersigned shall comply fully with The Racing Rules of Sailing and by all other rules that govern this event, sailing instructions, and safety requirements set forth by the race committee and those required by all jurisdictions, local, state, and federal, and that the undersigned has in force and effect a policy of liability insurance which covers the owner, skipper, crew, and vessel while engaged in the contemplated activity.
